As Parent/Guardian, I enter into the following agreement with Village Theatre Institute:

TUITION

Tuition for the 2018-2019 year is **\$2,050.00** for Pathway to Institute and **\$2,240.00** for Institute.

1. Payment is **due in full by September 1st, 2018, unless a payment plan is in place.**
2. Parent/Guardian and student are entering into a nine-month commitment to Village Theatre Institute/Pathway to Institute, and agree to pay the tuition specified in full, even if the student chooses to withdraw from the program before completion for any reason.

DEPOSIT

1. In order to reserve a place in the Institute/Pathway program, a **non-refundable deposit of \$250.00** for Pathway and **\$350.00** for Institute will be collected by **July 18th**, 2018. This deposit is applied toward the tuition. This is separate from any payments made toward a payment plan.

PAYMENT PLAN

1. Parent/Guardian will provide authorization for a credit/debit card to be charged monthly.
2. Tuition payments of **\$200.00** per month for Pathway and **\$210.00** per month for Institute will be charged to the card on file on or after the **FIFTEENTH (15th)** day of each month, beginning in September (9 months total).

REFUNDS

1. The registration deposit is non-refundable under any circumstance.
2. Refund schedule for tuition:
 - Any tuition, **less the non-refundable registration deposit**, is refundable if the student cancels participation in program prior to September 1st, 2018.
 - Students enrolled in the Institute/Pathway to Institute who wish to withdraw **after** September 1, 2018 are obligated to pay the remainder of their **tuition in full**.
