Mainstage productions focus on excellence in family theatre, developing a broad based appreciation for live theatre and promoting positive values through art. A Mainstage season of four musicals and one play were planned from September to August at two venues in Issaquah and Everett, Washington. Due to COVID-19, the Theatre was shuttered on March 12, 2020 due to a government order from the governor. As a result, the last two shows of the season and remainder of the run of She Loves Me in Everett were cancelled. Attendance was 74,356 at 220 performances.

4b (Code:) (Expenses \$ 391,126 including grants of \$ 0) (Revenue \$ 14,033)
Village Originals is a mission driven program to commission and produce new musicals that achieve national exposure. Through the Village Originals program, new works are produced to various degrees in collaboration with the show's creators. This process helps to foster the growth of new musicals in America and around the world. Due to COVID-19 the Village Originals program was very limited in it's programming. A Developmental Production of XY was produced in February 2020 and was attended by 818 patrons. A Developmental Production has minimal sets and costumes but it allows the creative team see how their production does in front of a live audience. Village Theatre is one of only a handful of professional theatre companies throughout the country that commissions and develops new musicals. Village Theatre's reputation in this arena continues to grow on a national and international level. The Village Originals program continued to work with writers during COVID-19 on uncompleted scripts. The Program helped writers to develop ideas, create material, test drafts, provide feedback and receive dramaturgical support.

4c (Code:) (Expenses \$ 1,261,956 including grants of \$ 0) (Revenue \$ 948,902)
KIDSTAGE trains young people in theatre skills for career opportunities and enriched lives by offering classes and performance opportunities. KIDSTAGE education programs consist of year-round classes and camps; and performance opportunities in two locations: Issaquah and Everett, Washington. Enrollment in classes was approximately 2,153 students. KIDSTAGE produced 3 musicals throughout the year between both locations. An audience of 4,298 attended 29 performances. Some of the performance opportunities are provided at no cost to the students; while others are tuition based. Due to COVID-19 many KIDSTAGE productions were cancelled; however many classes were able to continue as KIDSTAGE moved to an online format in response to the pandemic.

Form 990, Part III, Line 3 - As a result of the spread of COVID-19 and at the government's direction, the Theatre stopped production of all plays and events effective March 12, 2020. Our youth education classes continued in an online format; however tuition revenues were still negatively impacted as a result.

Form 990, Part VI, Section B, Line 11b - Form 990 Part VI Section B Line 11B At an annual board meeting the board assigns responsibility for formal review of the 990 to the finance committee and authorizes the executive committee to approve the return for filing. They also authorize the Executive Producer to sign the return. The formal review is scheduled once the return is completed. Any board members who are not members of the finance committee who are interested in formally reviewing the return are invited to attend the meeting. Prior to the finance committee meeting, management emails the completed return to all voting board members. Any feedback or comments are discussed and approved by the committee. The Treasurer leads the review process and the preparer, a licensed CPA, is on hand to answer questions. At the following executive committee meeting the finance committee recommends approval by the executive committee who is authorized to act on behalf of the full board. After approval by the executive committee, management electronically files the return with the IRS.

Form 990, Part VI, Section B, Line 12c - Annually the board is given a copy of the Conflict of Interest policy and then asked to sign a certificate of acknowledgement that affirms that they have read and understand the policy and have agreed to comply with the articles of the policy. Additionally, the board annually fills out a board questionnaire that inquires about family or business relationships that may be potential conflicts, as well as, inquiring about business transactions and compensation.

Form 990, Part VI, Section B, Line 15 - For the fiscal year ending 8/31/20, the executive committee and the board of directors of Village Theatre established an executive compensation and performance review committee. This committee meets twice a year to review the goals and performance of the Executive Producer. The committee evaluates the CEO salaries at comparable theatres in the National Alliance for Musical Theatre salary survey and selected 990 tax returns for regional theatres in the Seattle area and around the country. The committee brings their Executive Producer compensation recommendations to the full board for approval. Other key employee's salaries are presented at the finance committee for review as part of the annual budgeting process which is approved by the full board.

Form 990, Part VI, Section C, Line 19 - The organization makes governing documents, conflict of interest policy and financial statements available to the public upon request. Additionally, audited financial statements and 990's are posted on Village Theatre's website and are available to the public for download. The 990 is also posted on Guidestar. Each year the organization produces an annual report that provides summary financial information. Form 990, Part XI, Line 9 - During the year ended August 31, 2020 the Theatre adopted the following Financial Accounting Standards Board's Accounting Standards Updates (ASU): ASU No. 2016-18 - Statement of Cash Flows: Restricted Cash. This ASU requires that restricted cash be reflected in the total change in cash, cash equivalents, and restricted cash on the statements of cash flows. The Theatre implemented this ASU retrospectively for all periods presented in the financial statements. ASU No. 2014-09 - Revenue from Contracts with Customers (Topic 606) and other related ASU's. These ASU's replaced the existing revenue recognition guidance in US GAAP and require entities to recognize revenues when control of the promised goods is transferred to customers at the amount that reflects the consideration to which the entity expects to be entitled to in exchange for those goods or services. The primary effect of adoption of these ASU's of the Theatre is that advertising costs for future periods are now expensed as incurred. Previously the Theatre deferred advertising costs related to future productions and recognized them as expense in the period those productions occurred. The Theatre elected to adopt the changes from these ASU's using the full retrospective method, which required the Theatre to restate the financial statements for August 31, 2019.
